That's why almost all assassins in horror movies have a mentality of hatred and suspicion, but the reason for tragedy is that they cannot face their dark inner psychology correctly.

In order to create a terrifying atmosphere in Chinese and American films, directors often use narrow and enclosed spaces to create terrifying environments, which is a similar technique in Chinese and American horror films. They all make good use of enclosed spaces such as restrooms, elevators, corridors, and bathrooms. Usually in horror movies, there are scenes like this: when the protagonist is in the bathroom, a ghost with long hair and rotten skin floats out of the water, or blood flows out of the water pipe, or suddenly finds someone standing behind them reflected in the mirror. All these terrifying scenes are terrifying enough to make your hair stand on end.

Both countries' horror movies make good use of the timid feelings we experience in our lives. When we focus on the story of the movie accompanied by soft and slow music, suddenly there is a terrifying sound or a ghostly face, with blood on the lips, hollow eyes, and the audience's sense of fear and terror reaches its peak. At the same time, the melody of the music reflects the audience's mental state.

4. DIFFERENCES IN HORROR STORY THEMED FILMS BETWEEN CHINA AND THE UNITED STATES.

4.1 Differences in Ghosts

Therefore, the ghost culture in the United States is visible, and they focus more on the visual aspect. However, China is influenced by the fictional and illusory culture, and has come up with many spiritual perspectives. On the other hand, the ghost culture between China and the United States is completely different. In American horror movies, "most American ghosts are extremely bad, fierce, cruel, and physical. They are mostly mummies, vampires, or similar things." (Anna, Harris, 1993) There have always been two forms of ghosts: one is a decaying corpse, and the other is a creature from other spaces, representing aliens. They may look disgusting and annoying overall, but when you look at them, you have the ability to protect yourself from these terrible things. The fear and terror stirred up by classical horror movies, through external threats such as foreign invaders from other territories and bloodthirsty demons, left little sense of fear for the audience at that time. The ghost culture in China is completely different. He is non physical and invisible, no one knows where he will appear or when he will suddenly appear behind you. Usually, they are the souls of the deceased and their appearance has not changed much. At the same time, feudal superstitions also influenced Chinese ghost movies.

On the other hand, in horror movies, there may also be gender differences. In Chinese horror movies, the ghosts and monsters we see are usually women, but in Western horror movies, there is no such gender bias. For example, in Western horror movies, murderers such as Chainsaw Killer, Ghost Street, and Silent Lamb are all men. This difference is closely related to traditional culture. Taoism plays a significant role in China's profound traditional culture, with the most important work being the Book of Changes, another theory that balances yang and yin. We can learn about it from similar names such as Hades and Ghosts. Additionally, women are weaker than men and are more prone to experiencing terrifying hallucinations.

4.2 The Different Effects of Horror Movies on People

In Chinese and American horror movies, there is a significant difference in attitudes towards ghosts and monsters. Both countries acknowledge the negative effects of superstition, the dead, bloody scenes, and violence. However, so far, educators in the Chinese academic community still hold the view that minors will imitate the negative effects that appear in horror movies. In the United States, there is a further understanding of the impact of horror movies on people and society. They believe that evil thoughts will be eliminated in the process of watching horror movies. For example, if someone has a desire to commit murder, they can indirectly obtain satisfaction from horror movies, so the real murder will not happen to them in reality.

The background of American horror movies is mainly about the human vampire and devil series "(Anna, Harris, 2002). For example, the Texas chainsaw killer depicts distorted human nature and abnormal behavior using bloody scenes to create a terrifying effect. To some extent, this horror is rational and will make the audience think deeply after watching the movie. They believe that humans have a dual personality nature and always have the impulse to make mistakes. Therefore, Westerners usually let God understand their sins or ultimately let pastors understand their inner thoughts. Meanwhile, the country requires legal assistance. It is different from Chinese horror movies, where the main events in the film are non-existent in real life, such as ghosts, spirits, and so on. Sometimes, it can cause people mental anguish, which cannot be solved solely by the law. Therefore, China's management of the entire country is a combination of morality and law.

4.3 Different Attitudes Towards Individuals and Collectives

Western culture emphasizes individualism, while Eastern culture emphasizes collectivism. Chinese culture places too much emphasis on collectivism and rarely respects individual experiences, including experiences that span the horror psyche. This difference is more prominently reflected in horror movies. In American horror movies, humans not only have to fight against natural disasters, but they also have to face pressure from society and government. Therefore, such movies often exaggerate the protagonist's personal abilities. However, Chinese horror movies always focus on the social contributions of the protagonists and tend to use the power of the entire country and collective to solve problems. That is to say, Chinese horror movies prefer educational films to train people on how to deal with misfortune. However, the United States is more focused on arousing the audience's individualistic thinking.

5. CONCLUSION

The significance of horror movies has surpassed the influence and achievements of the films themselves. It contains social, cultural, and political meanings and functions, and gender issues, aesthetic and psychological influences make it an indispensable and important part. The process of appreciating horror movies is similar to a constantly evolving psychological game, which can help the audience relax and alleviate their life stress. That's also why horror movies are so popular. This article compares the similarities and differences between Chinese and American horror films, in order to contribute to the future development of Chinese horror films.
